### **STAFF**

RCI is proud of the team of over 700 employees that comprise our company. We have a number of degreed professionals, long-term supervisors and superintendents and experienced technicians. Our staff includes landscape architects, engineers, environmental specialists, licensed irrigation installers, licensed horticulturists, golf course superintendents, turf agronomists and more.

RCI has been enrolled in the E-Verify program since its inception. This program ensures that all of our staff assigned to your property are legal U.S. citizens or are registered with the Department of Homeland Security and have been authorized to work in the United States as required per law. This means that RCI will employ a fully-documented workforce that has undergone all necessary vetting and background checks as required. This is a critical component of the services we offer, as employees will be working among residents on a regular basis.

Specific to this project, RCI will assign the following staff:

### Regional Manager:

This position is responsible for overall quality control and is on site at a minimum of every other week.

### **Mowing Supervisor:**

### **Detail Supervisor:**

The detail supervisor will directly manage and work with the dedicated crews that are responsible for the pruning, hedging, chemical applications and other horticultural services performed to ensure the highest level of quality and appeal of your landscape.

### Technicians:

Licensed Chemical Applicator, Staff Horticulturist, Irrigation Manager. RCI has degreed professionals that are integral to the management of the property. This level of expertise and staffing is one of the things that sets RCI apart from our competitors. Our Staff Horticulturist and Licensed Spray Technicians will proactively address issues on the property to create the most appealing landscape possible.

RCI will fulfill the services on the project by engaging four specialized crews as well as technical staff.

Our mowing crew will be solely dedicated to the all mowing operations, including large-scale mowing, finish mowing, string trimming, edging and removal of debris generated during operations.

Our dedicated "detail" crew will perform all recurring horticultural services, including: hand weeding, pruning of shrubs, small scale chemical applications, litter control in landscape beds and more.

RCI's chemical application crew will be responsible for all large, seasonal chemical applications throughout the property. This work is performed by commercially licensed spray technicians under the supervision of experienced chemical applicators.

Any irrigation monitoring and repairs that may be necessary will be completed by experienced irrigation technicians assigned to the property.

Lastly, in order to avoid disruption of recurring maintenance services, RCI will deploy separate enhancement crews to perform any additional landscape projects that may be desired, change-outs of seasonal color, re-mulching of the properties and so forth.

By diversifying our approach, we will provide more coverage on the property in a focused manner.

### **EQUIPMENT**

With the proper personnel in place, we will then provide the necessary equipment needed to complete the work.



### **Scope of Work**

### Mowing

All grass and grass areas shall be cut more frequently during the growing season and as needed during the dormant season. Mowing height will vary depending on the time of year and the turf type. See the attached schedule of frequencies under mowing services for additional details.

### **Trimming**

All grass and grass areas that cannot be reached by mower shall be stringed-trimmed with every mowing. See the attached schedule of frequencies under mowing services for additional details.

### **Edging**

All sidewalks, walkways, curbs, and flowerbeds shall be edged to form a separation line from the grass. Hard lines will be edged with every mowing and bed lines will be edged monthly. See the attached schedule of frequencies under mowing services for additional details.

### **Fertilization**

All grass areas will be fertilized with a commercial grade fertilizer to maintain a healthy turf. The frequency of these applications will be determined by turf type, soil analysis, and type of fertilizer used. See schedule of frequencies for additional details.

### **Weed Control**

All turf areas will receive pre and post emergent applications to control weeds in turf areas. The best form of weed control is a healthy turf and we will integrate all of our services to promote a healthy environment.

### **Insect Control**

All turf will be treated as needed to prevent or limit damage to turf caused by insects. This does not included the prevention of fire ant infestation or nematode control. These treatments are available at an extra cost.

### Hedging

All landscaped shrubs, bushes, and plants shall be hedged to its original form so as to maintain its shape. This will occur one (1) time every four (4) months or as necessary during the rapid periods of growth.

### **Pruning**

All trees and shrubbery, less than ten feet (10') in height, shall be pruned to its original form so as to maintain its shape. All unwanted growth and damaged limbs shall be removed one (1) time per year.

### **Blowing & Debris Removal**

All grass clippings and leaves will be blown from all walkways, sidewalks, curbs, and breezeways after every mowing. All other debris created by Herbafex, Inc. shall be removed from property. Acts of nature are excluded. Debris created by acts of nature can be removed by contractor for an additional fee.



### **Weed Control**

All landscape areas will be weeded by hand or Round-Up will be used as circumstances permit. Once weed problems are controlled, a preventative maintenance program will be implemented. Weed control will be performed on an as needed basis.

### Irrigation

Irrigation will be inspected and adjusted monthly. During these inspections, irrigation heads will be adjusted to ensure proper coverage and any needed repairs will be noted and reported to the client. Herbafex, Inc. agrees to provide the labor and materials for all above ground repairs caused by the contractor. In the event that repairs which are not caused by the contractor are needed, the contractor will perform work for \$45.00 per hour plus parts.

### **Additional Services**

### Mulch

Pine Straw will be installed in all beds. All bed edges will be edged to keep a clear definition between the mulch and the turf/hard edges. Mulched areas will be inspected on days of service to maintain them relatively weed free.

### **Palm Pruning**

All palms will be pruned to remove fruit pods. Palm fronds below 9 and 3 o'clock will be removed and all loose boots will be removed at the time of pruning.

### Seasonal Color

Annuals will be replaced twice per year with 4" plants appropriate for the season. At the time of install, annual beds will be amended with fertilizer, insecticide, and fungicide. Follow up applications will be made twice per month to maintain a healthy plant.


