## **APPROVAL OF PREVIOUS MEETING MINUTES**

Motion Nancy Stovall to approve June 25, 2018 Board of Directors meeting minutes. Second by Glenn Holliday. Motion passed unanimously.

### **OLD BUSINESS:**

Discussion about the need for fans in the elevators. Several Board members had been by Sterling Beach to check out the fans in their elevators. Motion by Glenn Holliday to accept a quote from Affinity Elevators to install fans in the 3 elevators in Tower 1 at a cost of \$1850.00 per elevator. Seconded by Dean O'Reilly. He stated in January 2018 that Philip Sullivan asked for a one year extension of the current agreement. Chuck Rachke read a statement form Emerald View.

Regardless of what a small group of owners may say, we have worked hard at keeping this building in great condition over the last ten years and have kept the dues among the lowest on the beach. Ultimately, we decided not to send a proposal to continue management because it became clear that the certain members of the board and some owners were not satisfied with our performance. We have worked hard with the current board to execute the initiatives they set forth. If the job we are doing is not satisfactory, it is simply time for the board to select a different management company.

Philip Sullivan Controller Emerald View Resorts

Frank Booke presented management bids from Resort Collection and Burg Management. Resort Collection was for 3 years at \$127,000 1<sup>st</sup> year, \$132,000 2<sup>nd</sup> year, and \$137,000 3<sup>rd</sup> year. Burg Management was \$150,000 per year with a

administrative assistant. Motion by Peter Morreale to negotiate with Resort Collection for an acceptable agreement. Seconded by Dean O'Reilly. Motion passed unanimously.

#### **NEW BUSINESS**

Terms of the Board members. Board would like to see staggered terms as per the Declaration starting at the next election.

Limited Proxy. Motion by Glenn Holliday to accept and forward to the owners the limited proxy as written by Tim Sloan Association legal counsel. Seconded by Dean O'Reilly. Motion passed unanimously.
