#### QUITCLAIM DEED

This Quitclaim Deed is effective ~~January~~ <sup>February 22</sup>, 2022 by and between **360 PANAMA FLATS, LLC**, a Georgia limited liability company, whose mailing address is 3284 Northside Parkway NW, Suite 125, Atlanta, Georgia 30327 ("360 Panama"), and **GRAND PANAMA BEACH RESORT CONDOMINIUM ASSOCIATION, INC.**, a Florida not-for-profit corporation, whose mailing address is 11800 Front Beach Road – Office, Panama City Beach, Florida 32407 (the "Association").

This Property (as hereinafter defined) is not the homestead of 360 Panama.

WITNESSTH, that 360 Panama, for and in consideration of the sum of Ten and No/100 Dollars (\$10.00), and other valuable considerations, the receipt whereof is hereby acknowledged, hereby grants, bargains, sells, aliens, remises, releases, conveys and confirms unto the Association, all that certain land lying in Bay County, Florida and described on Exhibit A attached hereto and incorporated herein by reference (the "Property").

TO HAVE AND TO HOLD, the Property unto the Association and its successors and assigns forever.

360 Panama makes this conveyance in compliance with Section 7 of that certain Amended and Restated Ingress/Egress Easement Agreement dated December 9, 2020 and recorded on December 10, 2020 in O.R. Book 4335, Page 2326, Public Records of Bay County, Florida (the "Ingress/Egress Easement Agreement"). The Association confirms that this Quitclaim Deed complies with the requirements of such Section 7.

The conveyance is subject to the following:

- (1) All matters of record and to all matters that would be shown on an accurate survey and current inspection of the Property. 360 Panama makes no warranty, express, implied or otherwise as to its title, if any, to the Property or the condition of the Property, which is conveyed as "AS-IS, WHERE-IS AND WITH ALL FAULTS" without representation or warranty of any kind. For the avoidance of doubt, the Property shall remain subject to and encumbered by the terms and conditions of the Fire Lane Easement (as such term is defined in the Ingress/Egress Easement Agreement) referenced in Section 4 of the Ingress/Egress Easement Agreement.
- (2) The Property shall only be used for vehicular parking and as an access drive. This restriction is for the benefit of 360 Panama's property identified on Exhibit B attached hereto and incorporated herein by reference (the "360 Panama Property").
- (3) No building or any other vertical structure shall be erected or maintained on any portion of the Property. This restriction is for the benefit of the 360 Panama Property.
- (4) The fire lane located within the Fire Lane Easement Area (as defined below) shall remain free, unimpeded and clear at all times and shall not be relocated by the Association. In the event that the Fire Lane Easement Area is blocked for any reason whatsoever, the owner of the 360 Panama Property shall have the immediate right, without any prior notice to the Association, to clear any such blockage (including towing any vehicles) at the sole cost and expense of the Association. This restriction is for the benefit of the 360 Panama Property.
- (5) 360 Panama reserves a permanent, perpetual, non-exclusive easement for the benefit of the 360 Panama Property over, through, and across the Property for the purpose of (i) connecting to and/or installing utilities to serve the 360 Panama Property and (ii) using, maintaining, repairing, relocating, and replacing such utilities, but such use shall not diminish the use of nor decrease the number of parking spaces then-located on the Property.
- (6) 360 Panama retains and reserves the use of the Property as acreage for the purpose of any density requirements for the 360 Panama Property, and in no event shall the Property be used by the Association or any successor or assign as acreage for the purpose of any density requirements. This reservation is for the benefit of the 360 Panama Property.
- (7) 360 Panama retains and reserves a permanent, non-exclusive easement for the benefit of the 360 Panama Property over, through, and across the

Property in the area described on Exhibit C attached hereto and incorporated herein by reference (the "Fire Lane Easement Area") for the purpose of fire lane access from the 360 Panama Property to Front Beach Road. The Association shall be responsible for all maintenance, repair, and replacement of the Fire Lane Easement Area such that the same is kept at all times (i) in good condition and state of repair, (ii) in compliance with all laws, rules, and regulations of governmental authorities exercising jurisdiction thereover, and (iii) in compliance with the terms of this Quitclaim Deed and the Ingress/Egress Easement Agreement. For the avoidance of doubt, the Fire Lane Easement Area referenced in this Quitclaim Deed is separate from, but connects with, the "Fire Lane Easement Area" referenced in that certain Ingress/Egress Easement Agreement and shown on Exhibit C attached to this Quitclaim Deed;


- (8) In the event the Association fails to maintain the Fire Lane Easement Area in accordance with the terms of this Quitclaim Deed and the Ingress/Egress Easement Agreement or breaches or fails to comply with the terms and conditions of this Quitclaim Deed and the Ingress/Egress Easement Agreement, 360 Panama shall have all the rights and remedies available in the Ingress/Egress Easement Agreement with respect to said failure or breach.
- (9) 360 Panama retains and reserves a non-exclusive, perpetual easement for benefit of the 360 Panama Property over, through, and across a four foot wide rectangular strip of land and a ten foot rectangular strip of land running the entire length of the western and eastern sides (respectively) of the Property currently improved with a chain link fence that is more particularly identified on Exhibit A hereto as "5' TALL CHAIN LINK FENCE." This easement is for (i) encroachment of such chain link fence and (ii) maintaining, repairing, and replacing such fence. Any such maintenance, repair, or replacement shall be at 360 Panama's expense.

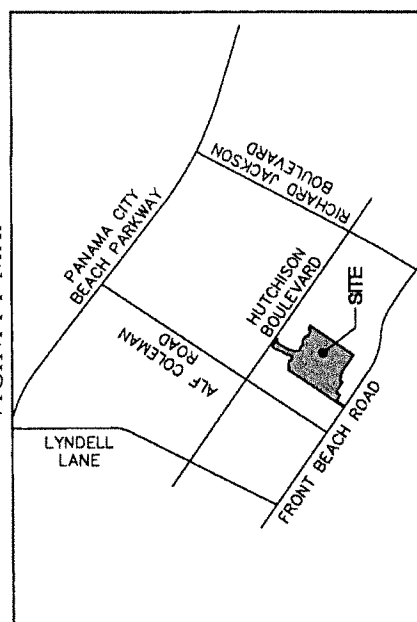

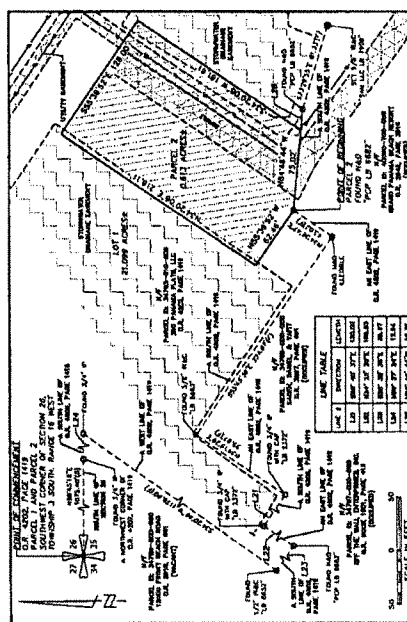
